Andrea Horne she/her/hers	\$50,000	San Francisco Arts Commission funds will be used to support Andrea Horne’s publication of the series How Black Transgender Women Changed the World. Additionally, two public events will be held: one, a participatory exploration of transgender history, stories, and culture focused on preserving transgender experience in San Francisco; the other, a book launch featuring a spoken word and musical performance by Andrea. These events engage audiences to contribute to living historical memory, honoring transgender history.

This programming includes dynamic panel discussions that highlight the composers’ music and lived experiences.

Skywatchers artists will co-create "Calling Us In", a collaboration with guest choreographer Sarah Crowell in partnership with Glide, exploring radical inclusion and community accountability from the front lines of our most intractable crises.
Audium Incorporated	\$100,000	San Francisco Arts Commission funds will be used to support the continuation of Audium's Residency Program, which provides Bay Area artists from underrepresented communities with paid opportunities to create and perform spatial sound compositions. Resulting performances expose audiences to new voices with socially-imperative messages and spark dialogue around community experience. Funds will be used to pay nine local artists and support the wages of the staff members who make the program possible.
Brava for Women in the Arts	\$100,000	San Francisco Arts Commission funds will be used to support Brava's Artists-in-Residence and Presenting programs and celebrate the 100th anniversary of our historic theater. These programs provide abundant multi-year support for local artists including performance and rehearsal space, production management, grant and fiscal sponsorship services, and a permanent home to create within and beyond Brava's walls. Brava will use the funds to pay Artists fees, productions costs and facility expenses related to these cornerstone programs.

This support will allow us to continue delivering free, socially relevant performances and workshops across San Francisco's neighborhoods, empowering marginalized voices and fostering community dialogue. By keeping our artists thriving, this grant secures our ability to serve as an enduring cultural force within the city.
