La Pocha Nostra Inter-Cultural Performance & Comm Arts Projects	\$40,000	San Francisco Arts Commission funds will be used to support legacy planning sessions in 2023 and a public program comprising 40+ years of pioneering interdisciplinary art by Guillermo Gómez-Peña, LPN's Founder and Artistic Director. Using participatory performance, media and pedagogy, elements of the artist and organization's unique "living archives" will be reimagined, activated and made accessible at Saint Joseph's Art Society in 2024 through a workshop for local artists and public performance.

Youth Art Exchange Planning Fiscal Sponsor: Tides Center	\$50,000	San Francisco Arts Commission funds will be used to support a critical phase of capital campaign planning focused on 1) strategy development for fundraising for YAX’s Balboa Upper Yard site, and 2) management and implementation of the strategy. This is the second of two locations YAX is developing as youth and community arts hubs on the ground floor of Mission Housing Development Corporation’s 100% affordable housing units. The other location under development is 1950 Mission Street.
Womens Audio Mission Facilities Improvement Level 2	\$100,000	San Francisco Arts Commission funds will be used to support a major spatial audio/7.1.4 monitoring upgrade to WAM’s recording studios, making them one of the most cutting-edge immersive audio facilities in California. Leveraging a major investment and technical support from Dolby Labs, this upgrade allows WAM to provide access to Dolby Atmos Certification Training and spatial audio technologies to women/gender-expansive artists/music producers, giving them a crucial advantage in an emerging music industry platform.
Yerba Buena Arts & Events Planning	\$50,000	San Francisco Arts Commission funds will be used to support the planning and design of shade structures that would provide much needed cover for audiences and artists at the Yerba Buena Gardens Festival. This project would significantly improve and upgrade Yerba Buena Gardens and its open air performance venue that engages 80,000+ audience members and presents 1,200+ artists in downtown San Francisco every year.
Art of the Matter Performance Foundation Facilities Improvement Level 1	\$50,000	San Francisco Arts Commission funds will be used to support the completion of Studio 210’s lighting/equipment upgrade. The upgrade will include new LEDs and LED retrofits for better energy efficiency, providing greater flexibility with the studio’s limited power, as well as the purchase of an additional riser and new chairs, improving audience sight lines and providing comfortable and accessible audience seating. These upgrades will allow us to offer affordable and well-equipped space to underfunded artists.

Bindlestiff Studio Facilities Improvement Level 1	\$36,161	<p>San Francisco Arts Commission funds will be used to support improvements to the amenities offered to audience/artists/renters, such as more comfortable chairs, better audio/visual equipment, new colored curtains, more privacy in gender-neutral bathroom stalls, and energy-efficient stage lighting to keep the space cooler. We hope these improvements help draw more visitors to the Sixth Street corridor.</p>
Magic Theatre, Inc. Facilities Improvement Level 1	\$50,000	<p>San Francisco Arts Commission funds will be used to support upgrades to the theatrical lighting grid and new carpet in the lobby, dressing rooms, lounge areas, and stairs. The upgrades will improve the audience's experience at our theater and expand creative possibilities for local artists. Reinforcing the lighting grid's anchoring system to the ceiling and replacing pipe sections will strengthen the grid's capability to support heavy weight-bearing loads, and we'll permanently install our projection screen.</p>

The initiative will formulate and implement a new social marketing strategy and a new fundraising approach that will expand 3rd i's audiences and increase our annual operating budget to \$200,000 by CY 2025.

Additionally, to support our annual Open House convening for alumni and art workers, network engagement, outreach, and a \$10K yearly scholarship fund with a focus on San Francisco-based BIPOC, LGBTQ+, and women-identified arts and culture practitioners to participate in TGW.</p>
Aunt Lute Foundation	\$100,000	<p>San Francisco Arts Commission funds will be used to support Aunt Lute in maintaining overhead expenditures as we establish a foundation for our future in the publishing industry. We will use SFAC funds to maintain our current marketing and outreach model for our upcoming publications, so we can continue direct, intentional contact with our literary community while we expand our technological capabilities across the board to remain competitive in the changing publishing landscape.</p>
