As the City agency that champions the arts, we are committed to making sure that the arts and culture community is represented at the table when important policy discussions take place. In 2014, I participated in an interagency Nonprofit Displacement Working Group that was convened by Mayor Lee and District 6 Supervisor Jane Kim. Together we put forward a list of recommendations to help mitigate the real estate pressures impacting nonprofit organizations. In response to this report, the Board of Supervisors voted to allocate \$4.515 million for a Nonprofit Displacement Mitigation Fund to provide assistance to nonprofits facing eviction. The Arts Commission is working with the Northern California Community Loan Fund (NCCLF) to ensure that \$2 million of those funds go towards technical assistance and grants to help arts nonprofits find secure, long-term real estate solutions.

With percent-for-art funding generated by the new North Beach Branch Library, the **Public Art Program** commissioned world-renowned sound artist and neighborhood resident Bill Fontana to create a unique sound sculpture for the exterior of the new library. *Sonic Dreamscape* features an array of sounds that reflect the neighborhood's unique history and culture.

In addition to a suite of permanent public art projects being developed for the new Central Subway Chinatown Station, the **Public Art Program** commissioned Kota Ezawa to create a temporary mural for the construction site barrier. On view for one year, *Panorama* spans approximately 150 feet and features a series of re-drawn photographs of various artists' projects, geographic locations, historic and contemporary events where the horizon line is prominently featured.

PRESERVING THE CITY'S HERITAGE

In District Three, artworks that received restoration treatment included:

- Coit Tower murals located on the ground floor underwent a major conservation. In addition to repairing environmental damage, the Arts Commission implemented a new suite of didactic signage to bring the artist and the artworks to life.
- Dan Rice's 1985 oil on canvas painting *Drive Me Up the Wall* was conserved and reframed as part of the SFMTA renovations to the parking facility at Moscone Center.
- Completion of Phase 1 of restoration of painted surfaces on Robert Arneson's *Yin and Yang*, 1992.
- The conservation of *Mechanics Monument* located on Market Street.

This fall, San Francisco dedicates its first Veterans Memorial. Designed by Susan Narduli and Andrea Cochran, *Passage of Remembrance* is a series of three reflection pools circumscribed by an octagon of stone. A walkway floats above the water and takes visitors through the memorial. The walkway is anchored on either side by basalt walls inscribed with a poem by World War I veteran Archibald MacLeish, titled "The Young Dead Soldiers Do Not Speak". The

new memorial will be located in Memorial Court, between the Opera House and Veterans Building—a space always intended for a veterans' memorial that contains soils from battlefields throughout the world where Americans have fought for their country.

What kind of place would San Francisco be without the arts? According to the Americans for the Arts' recent *Creative Industries: Business & Employment in the Arts* report, the city is home to over 5,000 arts businesses that employ approximately 30,000 people. In our current economic climate when issues around affordability are dominating news stories, it is important to take a look at what we value as a city and for all of us to play a role in protecting what makes San Francisco great.



As the City agency that champions the arts, we are committed to making sure that the arts and culture community is represented at the table when important policy discussions take place. In 2014, I participated in an interagency Nonprofit Displacement Working Group that was convened by Mayor Lee and District 6 Supervisor Jane Kim. Together we put forward a list of recommendations to help mitigate the real estate pressures impacting nonprofit organizations. In response to this report, the Board of Supervisors voted to place \$4.515 million on reserve for a Nonprofit Displacement Mitigation Fund to provide assistance to nonprofits facing eviction. The Arts Commission is working with the Northern California Community Loan Fund (NCCLF) to ensure that \$2 million of those funds go towards technical assistance and grants to help arts nonprofits find secure, long-term real estate solutions.

Three organizations in District 6 were selected by NCCLF to receive the first round of support from the Nonprofit Displacement Mitigation fund. CounterPulse, Root Division and Women's Audio Mission each received \$100,000 to assist with the build-out of their new spaces. Meridian Gallery, Cartoon Art Museum, SOMArts, Center for Sex and Culture and Theatre Flamenco among the other grantees who received technical assistance

Civic Design Review ensures excellence of the built environment through a three-phase review of structures and parks on City land. As part of the Boeddeker Park renovations, artist Amy Blackstone created a new decorative fence for the park perimeter that features a flower motif.





With funding from the National Endowment for the Arts, the SFAC contributed to a seven-story, 100-foot mural by Clare Rojas on the side of the historic Warfield Building.

With percent-for-art funds generated by the new Public Safety Building on 3rd and Mission, which is scheduled to open in fall 2014, the **Public Art Program** commissioned San Franciscobased artist Paul Kos to design a site-specific installation for the building's Community Plaza (pictured below left). Designed as a gathering space where people can enjoy the outdoors, the Plaza features a seven-point sculptural police star made of Sierra black granite and a bronze bell that will strike three times at noon to signify "All is Well."

The poem was written by Margo Perin, in collaboration with Attie and members of the Bay Area Law Enforcement Assistance Fund.

ART MARKETPLACES

San Francisco's street artists provide residents and visitors with a colorful outdoor marketplace that contributes to the economic life of the City. Since 1972, artists have sold their wares ranging from jewelry, photography, sculpture, apparel, leather craft, and blown glassware in the city's most visited areas. Currently there are about 467 street artists in the Arts Commission's program. Over 60% of the Program's street artists live in San Francisco. District Six has 118 spaces.

WHERE ART MEETS EDUCATION

WritersCorps, the award-winning program that places professional writers in community settings to teach creative writing to youth, served 44 students at Mission High School and 30 students at Sanchez Elementary School. In addition, the program supported three teaching artists.

Where Art Lives is an anti-graffiti curriculum that places urban artists in public schools to teach youth the difference between art and graffiti vandalism. The

program is the educational component of *StreetSmARTS*, a joint program of the SFAC and the Department of Public Works. In FY2014, this program served 12 students from the **Mission Beacon Community Center at Everett Middle School**.

ART MARKETPLACES

San Francisco's street artists provide residents and visitors with a colorful outdoor marketplace that contributes to the economic life of the City. Since 1972, artists have sold their wares -jewelry, photography, sculpture, apparel, leather craft and blown glassware - in the city's most visited areas. Currently there are approximately 467 street artists in the Arts Commission's program. Approximately 60 percent of program participants reside in San Francisco. A total of 380 artist spaces are located throughout the City and County of San Francisco.

In District Eight, there are a total of eight spaces located in the "mini-plaza" at the intersection of 17th, Castro and Market streets.

From the Director of Cultural Affairs Tom DeCaigny

What kind of place would San Francisco be without the arts? According to the Americans for the Arts' recent *Creative Industries: Business & Employment in the Arts* report, the city is home to over 5,000 arts businesses that employ approximately 30,000 people. In our current economic climate when issues around affordability are dominating news stories, it is important to take a look at what we value as a city and for all of us to play a role in protecting what makes San Francisco great.



As the City agency that champions the arts, we are committed to making sure that the arts and culture community is represented at the table when important policy discussions take place. In 2014, I participated in an interagency Nonprofit Displacement Working Group that was convened by Mayor Lee and District 6 Supervisor Jane Kim. Together we put forward a list of recommendations to help mitigate the real estate pressures impacting nonprofit organizations. In response to this report, the Board of Supervisors voted to place \$4.515 million on reserve for a Nonprofit Displacement Mitigation Fund to provide assistance to nonprofits facing eviction. The Arts Commission is working with the Northern California Community Loan Fund (NCCLF) to ensure that \$2 million of those funds go towards technical assistance and grants to help arts nonprofits find secure, long-term real estate solutions.

Six organizations in District 9 were selected by NCCLF to receive the first round of support from the Nonprofit Displacement Mitigation fund. Gray Area Foundation for the Arts was awarded \$50,000 to assist with the build-out of its new space on Mission Street, and Dance Mission, Artists' Television Access, Galeria de la Raza, The Roxie and Aunt Lute were among the other grantees who received technical assistance.

The recent legislation created by Mayor Lee and Supervisor Campos to establish the Calle 24 Latino Cultural District was a wonderful step toward preserving the neighborhood's unique history and character at a time of great change in the City. The SFAC is pleased to support a number of organizations in the corridor including Precita Eyes, which received \$100,000 towards neighborhood mural restoration.

In response to the City's affordability challenges' impact on the arts and culture community, Mayor Lee included a \$7 million Shared Prosperity for the Arts Package as part of his FY2015 Budget. The budget increase represented a 14 percent growth over previous budgets

and included a \$2 million two-year enhancement (a 50 percent increase) to the City's groundbreaking Cultural Equity Endowment Fund and \$1 million to Grants for the Arts to support small and mid-sized arts nonprofits, individual artists and historically underserved communities through grants and capacity building. Mayor Lee's Shared Prosperity for the Arts Package includes a \$3.8 million capital investment over the next two years in the City's Civic Art Collection and Cultural Centers and additional funding for arts education.

ENHANCING THE URBAN ENVIRONMENT

With percent-for-art funding generated by the Palega Park renovation, the **Public Art Program** commissioned two new art works for the park.

ENHANCING THE URBAN ENVIRONMENT

Civic Design Review ensures excellence of the built environment through a three-phase review of structures and parks on City land.

In FY2014, the Committee reviewed plans for:

- 1550 Evans Street, a San Francisco Public Utilities Water Division Project;
- Candlestick Point Streetscape Master Plan and Signage Plan, a joint project of the Office of Community Investment and Infrastructure and Lennar, a private development firm;
- Dogpatch Arts Plaza, a new public gathering space being developed in an unused dead-end street, and
- Exterior Treatments to Southeast Community Facility.

A joint program of the SFAC's **Public Art Program** and the Port of San Francisco, *Bayview Rise*, designed by the artist team Haddad Drugan, transforms the abandoned grain silos and elevator at Pier 92 with a large-scale, colorful mural that can be seen from miles away.

Nobuho Nagasawa's *Ship Shape Shifting Time,* located on the Islais Creek public pathway near the MUNI Maintenance Yard, is a

large-scale installation that pays homage to the Bayview's maritime past. The steel sculpture, painted in International Orange like the Golden Gate Bridge, is based on one-half of a World War II Liberty ship in true scale.

COMMUNITY ARTS RESOURCES

Bayview Opera House (BVOH), A \$5.7 million renovation was led by the San Francisco Arts Commission, which owns the property. Built by the Masons in 1888, the BVOH, is the oldest standing theater in San Francisco and survived both the earthquake and fire in 1906. It is the first and so far only building in San Francisco's District 10 to be included in the National Register of Historic Places. Run by the non-profit, Bayview Opera House, Inc., the facility is dedicated to providing arts education for at-risk youth year-round for free or at a low cost. The organization also presents many cultural events throughout the year for all ages, including art exhibits, concerts, plays and community celebrations, as well as the recently established 3rd on Third event. SFAC 2014 annual support: \$318,362.41.





San Francisco Arts Commission and San Francisco Public Utilities Commission Join Forces to Support the Arts in the Bayview

In March 2013, the San Francisco Arts Commission and San Francisco Public Utilities Commission (SFPUC) announced a partnership to bring a robust suite of arts investment activities to the Bayview neighborhood. With a two-year funding commitment from the SFPUC, the SFAC began implementing an array of arts programming that aligns with the mission and core values of the SFPUC. These investments provide expanded access for Bayview residents to create and participate in vibrant cultural activities throughout the community. The following highlights some recent activity:



What began as a pilot seeded with funding from the SFPUC, has since become a popular monthly community celebration featuring myriad arts activities for the whole family. The success of 3rd on Third is largely attributed to a steady funding source, which was made possible by District 10 Supervisor Malia Cohen who was successful in securing support from the City's General Fund to sustain the program over a two-year period. With the sun setting of these funds in the fall of 2015, the local community has come together to provide ongoing support so that 3rd on Third can continue to build momentum and bring positive change to the Bayview neighborhood.



The Opera House is currently undergoing a \$5.3 million renovation to improve the BVOH open spaces with greening and landscaping elements, provide ADA access within the building and throughout the grounds and enhance programming options to serve the immediate community as well as the Bay Area arts and culture community. The most notable change to the building will be the plaza redesign. Designed by acclaimed landscape architect Walter Hood in partnership with Tom Eliot Fisch\Knapp Architects, the renovated plaza will feature a number of amenities to energize the outdoor program area so that it is transformed into a multi-purpose and welcoming cultural and community commons. As part of a larger initiative to create opportunities for Bayview residents to have more hands-on experience with art-making and to understand the neighborhood's history through arts engagement, the SFAC, with funding from the SFPUC, launched a pilot grant program to support existing arts programs in the Bayview Hunters Point community with \$10,000 grants. The projects include a range of art genres including media, theater, dance, visual art, traditional arts and multi-genre with a target audience of special needs kindergarteners, elementary school-aged kids, teens, domestic violence survivors, military veterans, parents and seniors.

Sights and Sounds of Bayview: SFAC partnered with local public radio station KALW 91.7 FM and commissioned six radio segments that featured neighborhood locals who are making a difference in their community. Segments aired on the radio as well as through the SFAC's Deep Roots podcast and as videos on YouTube. The project culminated in a live listening event at the Bayview Opera House to a standing-roomonly crowd.

Arts Education



With funding from the SFPUC, WritersCorps, the SFAC's award-winning program that places professional writers in community settings to teach creative writing to youth, served 372 students over two years at Downtown High School, International Studies Academy, College Track SF, Bayview-Hunters Point YMCA and 3rd Street Youth Center & Clinic.

This is Where: Poems on Place and Memory was a poster series that was on display on Muni's T-Third Street Line light rail platforms in the Bayview from mid-June to mid-July 2014. The posters featured poem excerpts by seven youth, ages 14 to 17, who participated in WritersCorps workshops at College Track San Francisco, an educational nonprofit based in Bayview.

With support from the SFPUC, students at YMCA Bayview, Visitacion Valley Middle School, El Dorado Elementary School, Thurgood Marshall High School and **George Washington Carver** Elementary School learned the difference between sanctioned and unsanctioned art through Where Art Lives, an anti-graffiti curriculum that places urban artists in public schools to teach youth the difference between public art and graffiti vandalism. The program is the educational component of StreetSmARTS, a joint program of the SFAC and SF Public Works.







Creative Placemaking

StreetSmARTS is a joint program of the SFAC and Department of Public Works aimed at combatting graffiti by pairing urban artists with private property owners. With additional funds provided by the San Francisco Public Utilities Commission, the SFAC was able to transform seven facades from havens for tagging into community murals on the following buildings:

From the Director of Cultural Affairs Tom DeCaigny

What kind of place would San Francisco be without the arts? According to the Americans for the Arts' recent *Creative Industries: Business & Employment in the Arts* report, the city is home to over 5,000 arts businesses that employ approximately 30,000 people. In our current economic climate when issues around affordability are dominating news stories, it is important to take a look at what we value as a city and for all of us to play a role in protecting what makes San Francisco great.



As the City agency that champions the arts, we are committed to making sure that the arts and culture community is represented at the table when important policy discussions take place. In 2014, I participated in an interagency Nonprofit Displacement Working Group that was convened by Mayor Lee and District 6 Supervisor Jane Kim. Together we put forward a list of recommendations to help mitigate the real estate pressures impacting nonprofit organizations. In response to this report, the Board of Supervisors voted to allocate \$4.515 million for a Nonprofit Displacement Mitigation Fund to provide assistance to nonprofits facing eviction. The Arts Commission is working with the Northern California Community Loan Fund (NCCLF) to ensure that \$2 million of those funds go towards technical assistance and grants to help arts nonprofits find secure, long-term real estate solutions.

This District report gives you a snapshot of some of the other exciting work we are doing in your district. Please join us in sustaining San Francisco's unique character by supporting the arts.

ENHANCING THE URBAN ENVIRONMENT

SFAC and the Department of Public Works have continued to join forces in combating vandalism in the City with the **StreetSmARTS** mural arts program. StreetSmARTS connects established urban artists with private property owners to create vibrant murals, a proven and effective strategy for making property less vulnerable to graffiti vandalism. StreetSmARTS also aims to restore San Francisco's stature as a recognized, international destination for mural art. Once a frequent target of vandalism, 1552 Ocean Avenue now features a mural from Meagan Spendlove.

Civic Design Review ensures excellence of the built environment through a three-phase review of structures and parks on City land. In FY2014, the Committee reviewed plans for the new Balboa Park Pool.

With percent-for-art funds generated by the Cayuga Park renovation, the **Public Art Program** commissioned artist Eric Powell to create two painted steel gates for the park and catalogued and restored some of the park's existing sculptures by the former gardener, Demetrio Braceros.

WHERE ART MEETS EDUCATION

WritersCorps, the SFAC's award-winning program that places professional writers in community settings to teach creative writing to youth, served 65 students at the Excelsior Branch Library.

Where Art Lives is an anti-graffiti curriculum that places urban artists in public schools to teach youth the difference between art and graffiti vandalism. The program is the educational component of StreetSmARTS, a joint program of the SFAC and the Department of Public Works.

In FY2014, this program served 21 students from the June Jordan School for Equity.
